Commitment to privacy

We endeavour to protect user privacy in compliance with the Australian Privacy Principles (**APP**).

Protecting your privacy

We are committed to protecting your personal information and complying with our obligations under the *Privacy Act 1988 (Cth)* (**Privacy Act**) and other State and Territory laws governing the use of personal information (collectively, **Privacy Laws**) which regulate how personal information is handled from collection to use and disclosure, storage, access and disposal.

Personal information generally means any kind of information in any form about a person that identifies that person and includes sensitive information.

Who does our Privacy Policy apply to?

The Pump House's Privacy Policy applies to:

- All individuals whose personal information is collected in relation to the products and services offered by The Pump House;
- All individuals whose personal information is collected by us in the course of our functions and activities, such as service providers, contractors and prospective employees.

This Privacy Policy explains:

- the nature of the personal information we may collect from you;
- how we manage the personal information that we collect, use and disclose;
- how to contact us if you:
 - have any questions about our management of your personal information;
 - would like to access or correct the personal information we hold about you; or
 - would like to lodge a complaint with us regarding our compliance with Privacy Laws.

The information we may collect

As part of our function, The Pump House provides sales, service, design, installation and technical advice concerning pumping and irrigation equipment. The Pump House also collects personal information for specific market research and to determine market trends in the way customers source or utilise pumping and irrigation equipment.

The types of personal information we may collect include:

- identifying information such as name, date of birth and employment details;
- contact information such as home and business addresses, phone numbers, postal addresses and email addresses;
- government-issued identifiers including ACNs and ABNs;
- financial information, such as credit card details;
- biometric information and templates, such as voice recognition information; and
- information about activities, including farming or other commercial activities.

We may collect your personal information from various sources including:

- you or from a person authorised to provide us this information on your behalf; and
- third parties such as a service provider engaged by us or a third party who partners with us.

We do not create, use or store profiles of our customers. We only record information that we reasonably require to do business with you. Your full name, address, postal address, email address and phone number are taken each time you make a booking through our website and/or whenever you submit a query or suggestion, or request assistance with a booking. This is to ensure we can provide the most convenient and effective service to you, both now and in the future.

We may collect your personal information in order to send you our free e-newsletters containing industry or product information. Any personal information that you provide to us for the purposes of receiving e-newsletters can be deleted at any time by unsubscribing from the e-newsletter.

You generally have the right not to identify yourself when dealing with us where it is lawful and practicable for us to allow it. However, on some occasions we may not be able to do this.

If you do not provide or authorise the provision of personal information we request, we may be unable to provide you with some or all of our products and services, or the product and services of our trading partners.

By becoming or remaining a customer of The Pump House, by subscribing to or acquiring one of our products and services, or the products and services of any of our trading partners sourced through us, or by otherwise providing personal (including sensitive) information to us, you confirm that you and other individuals whose information you provide have consented to our collecting, using and disclosing your and their personal (including sensitive) information, however collected by us, in accordance with this Privacy Policy.

How we may use or share your information

We may use your personal details in any of the following ways:

- responding to and fulfilling your requests for our products and services;

- third parties whom we are authorised to represent if you acquire products or services through us;
- third parties with whom The Pump House partners or works with to improve its products and services offering and value;
- other parties to whom we are authorised or required by law to disclose information;
- in other circumstances, with your consent.

We acknowledge that you may click-through to third party sites from our website. We cannot assume any responsibility for information from and content of third party sites. Our Privacy Policy is applicable only to us and our website and accordingly we recommend that you also refer to the privacy statements of the other sites you visit.

How we secure your personal information

We take all reasonable steps to protect your personal information from misuse and loss and from unauthorised access, modification or disclosure. We store your information securely and have a range of security controls in place to ensure that your information and documents are protected. Our relevant employees are trained in relation to privacy and access to personal information is restricted to individuals properly authorised to do so.

We also take reasonable steps to make sure that the personal information that we collect, use and disclose is accurate, complete, up to date and relevant. We keep your personal information for only as long as it is required in order to provide you with products and services and to comply with our legal

How we communicate with you

To keep you informed quicker, where you provide us with an email address, we will send most communications to you by email. How you may access and control your personal information

You can ask whether we are keeping personal information about you by contacting us. If we have retained information on file, you may request a copy of it. You may also wish to apply to amend the information if you believe it to be incomplete, inaccurate or irrelevant.

We will generally provide you with access to your personal information if practicable (although an administration fee may be charged), and will take reasonable steps to amend any personal information about you which is inaccurate or out of date.

You can get in touch with us, through the contact details found at the foot of this Privacy Policy, to request the above any time you wish to do so.

In some circumstances, we may not permit access to your personal information, or may refuse to correct your personal information. Where this happens, we will provide you with reasons for this decision, seek alternatives and take any further legally required steps.

Do we disclose your personal information overseas?

We may need to disclose your personal information to organisations located outside of Australia from time to time in the ordinary course of our business. Most of these overseas organisations are services providers or related entities which provide support and assistance to us in delivering products and services to you.

Where we do, we take reasonable steps to ensure that your information is given the same type of protection as it is afforded within Australia. This may be through satisfying ourselves that the overseas organisation has controls in place to comply with Australian privacy laws, ensuring that the overseas organisation is located in a country which we believe has a similar privacy regime to Australia or through contractually or otherwise mandating the adequate management of the information.

If you wish to make a formal complaint, please provide your complaint in writing to our Privacy Officer. We will consider your complaint promptly and contact you to seek to resolve the matter.

Generally, we will contact you within 5 business days to acknowledge receipt of your complaint and to let you know who is managing your query. We will attend promptly to your complaint and will aim to respond to your concerns or otherwise keep you informed of our progress within 30 days.

If we have not responded to you within a reasonable time or if your complaint is not resolved to your satisfaction, you are entitled under the Privacy Act to make a complaint to the Office of the Australian Information Commissioner.
